ADMISSION INFORMATION – UBORA SACCO MEMBERSHIP
1. Entrance Fee - Each applicant shall pay a non-refundable entrance fee of KShs. 1,000. - Membership rights and privileges commence only after this fee and the initial share capital are paid. 2. Share Capital Requirements - For new members, the initial share capital requirement is 500 shares, equivalent to KShs. 10,000. - The authorized share capital of Ubora SACCO is 3,250 shares valued at KShs. 65,000/= in total, or such other minimum shares as may be amended by the Annual General Meeting (AGM) from time to time. - This amount, while non-refundable, earns dividends and is transferable upon withdrawal of membership. - Maintaining this minimum ensures every member has an ownership stake, voting rights, and eligibility for credit facilities. 3. Monthly Contributions - The minimum monthly contribution is KShs. 2,000, subject to amendment by the AGM. 4. Risk Fund Contributions - The Monthly contribution is KShs. 400. This is a compulsory insurance scheme applies to all members.
